For Independent School Districts (ISDs)

Q: What is SB 13, and why is it important?

A: SB 13 is legislation that will significantly change how library materials are managed and selected in Texas public schools. The Act is scheduled to begin with the 2025-2026 school year and will take effect immediately if it passes with a two-thirds vote in each house, or on September 1, 2025, otherwise. It shifts more control to school boards and parents and introduces new content standards. The bill also mandates the establishment of local school library advisory councils, revises material acquisition and challenge processes, enhances parental access to information (including access to library records and usage records), and reinforces CIPA compliance. Districts are required to adopt the TEA model policy for material acquisition, adhere to TSLAC standards for collection development, and implement policies prohibiting defined content. It's crucial to prepare now for these comprehensive requirements, which include updating collection development policies by the first day of the 2025-2026 school year, to avoid scrambling for compliance later
