# Overview of Senate Bill 13

SB 13 significantly impacts school district library operations, parental rights, and content standards. It mandates clear actions for districts to ensure compliance once approved by the Governor.

#### Key Mandates for School Districts (Effective September 1, 2025)

#### Parental Rights & Access:

Districts must provide parents full access to their child's library catalog and checkout history (including classroom, online, and mobile applications). Parents can also restrict their child's access to specific materials, and districts must provide usage and related school records upon request.

#### **Content Standards & Prohibitions:**

SB 13 defines "harmful material," "indecent content," and "profane content" and explicitly prohibits such material in school library collections, establishing clear standards.

#### Policy & Standards Adoption:

The Texas Education Agency (TEA) is required to adopt and make available a model policy for library material acquisition. School districts may choose to adopt this model, but are not mandated to do so. However, districts must adopt a policy for selecting library materials (including purchases and donations) and adhere to collection development standards adopted by the Texas State Library and Archives Commission (TSLAC) by April 1, 2026.

#### Local Library Advisory Councils:

Parents can petition for the formation of local advisory councils (by submitting a petition signed by at least 50 parents or by parents representing 10% of students in the district, whichever is fewer). These councils will advise on material acquisition and removal, with their recommendations being considered by the Board of Trustees. Councils must reflect community values.

#### Acquisition & Challenge Process:

Districts must establish and follow defined procedures for acquiring new library materials and for challenging existing ones. The Board of Trustees must adopt a policy for acquiring library materials.

#### Funding:

Districts are permitted to use their Instructional Materials and Technology Allotment for costs related to parental access and restrictions on library materials.

## The Challenges for School Districts

School districts face challenges in adopting and implementing new policies and standards, including creating a model policy for library materials, complying with collection development standards set by TSLAC, and prohibiting specific content.

They also need to manage library material acquisition and challenges by establishing new processes and procedures. Establishing and effectively utilizing local school library advisory councils that reflect community values and considering their recommendations is another hurdle.

Furthermore, districts must facilitate parental rights and access by providing catalog access, enabling restriction requests, providing usage records, and granting access to related school records.

Finally, training staff on these new definitions, processes, and parental access facilitation is crucial for compliance, along with understanding the funding implications related to providing parental access and managing restrictions.

The objective book intelligence data and challenge history provided by OnShelf are essential tools for informed decision-making by school boards and any local library advisory councils established under the 10%/50 rule (triggered when 50 parents or 10% of the student body—whichever is fewer—submit a petition). It offers transparency and data-driven insights to support their recommendations. OnShelf currently benefits book review committees by providing access to this same information, and a function to upload and manage related documentation.




