Summary of Senate Bill 13

Senate Bill 13 primarily focuses on the regulation of school district library materials and catalogs, parental rights regarding these materials, and the establishment of local school library advisory councils.

Key provisions of the bill include:

Parental Access and Restrictions:

It amends the Education Code to grant parents access to their child's check out history and access to library catalogue which includes school libraries, classroom libraries, online catalogues and library mobile applications. Parents are also given the right to restrict their child's access to certain library materials.

Content Standards:

The bill defines terms like "harmful material," "indecent content," "library material," and "profane content." It establishes standards for school library collections, explicitly prohibiting certain types of content.

Local School Library Advisory Councils:


Under the legislation, parents can request the formation of a local school library council by submitting a petition to the board—if it's signed by at least 50 parents or by parents representing 10% of students in the district, whichever is fewer. These councils will advise on the acquisition and removal of library materials, with their recommendations being considered by the Board of Trustees.

Acquisition and Challenge Process:

The bill details the procedures for acquiring new library materials and for challenging existing materials.

Policy and Standards:

The Texas Education Agency (TEA) is required to adopt and make available a model policy for library material acquisition. School districts may choose to adopt this model, but are not mandated to do so. However, the Board of Trustees of each district shall adopt their own library material acquisition policy, including procedures for procurement and handling of donated materials. Additionally, the Texas State Library and Archives Commission (TSLAC) must adopt standards for school library collection development by April 1, 2026. SB 13 takes effect as of September 1st, 2025, once signed by the Governor.



School District Compliance Actions for SB 13

To help you navigate Senate Bill 13, here's a breakdown of the key steps and activities you''ll need to consider for compliance.

Adopt and Implement Policies and Standards

- Adopt a Model Policy: School boards are required to adopt a policy that outlines how library materials are selected, including the process for purchasing new items and accepting donations.
- Comply with Collection Development Standards: School districts must adhere to standards for school library collection development adopted by the Texas State Library and Archives Commission (TSLAC).
- **Prohibit Certain Content:** Implement policies to prohibit "harmful material,""indecent content," and "profane content"in school library collections, as defined by the bill.

Manage Library Material Acquisition and Challenges

- Implement an Acquisition Process: The Board of Trustees of each school district shall adopt a policy for the acquisition of library materials. This policy must include specific procedures for both the procurement of new materials and the receipt of donated library materials.
- Implement a Challenge Process: Establish and follow a defined process for challenging existing library materials within the school district.



School District Compliance Actions for SB 13

Facilitate Parental Rights and Access

- **Provide Catalog Access:** Ensure parents can access the catalogue of available materials at each school library in the district or school. Includes school libraries, classroom libraries, online catalogues and library mobile applications.
- Enable Restriction Requests: Allow parents to request and implement restrictions on their child's access to specific library materials.
- **Provide Usage Records:** Supply parents with records of their child's library usage upon request.
- **Grant Access to Records:** Ensure parents have access to their child's school records, specifically those pertaining to library materials obtained from the school library.

Training and Awareness

 While not explicitly stated as a direct "action," implied compliance will require training staff (i.e. librarians, administrators, library aides etc) on the new definitions of prohibited content, the new acquisition and challenge processes, and how to facilitate parental access and restriction requests.

Establish and Utilize Local School Library Advisory Councils

- Create Councils: School boards may choose to create a local school library advisory council to help ensure library collections reflect community values. If at least 50 parents—or parents representing 10% of students, whichever is fewer submit a petition, the district is required to establish one.
- **Reflect Community Values:** Ensure these councils are structured to reflect community values in their recommendations for library catalogs.
- **Consider Recommendations:** The Board of Trustees must consider the recommendations made by these advisory councils regarding the acquisition and removal of library materials.

Funding Update

 SB 13 allows school districts to use their Instructional Materials and Technology Allotment (Section 31.0211) to cover costs related to providing parents access to the library catalog and managing individual restrictions on a student's access to specific library materials.


